**This Quarter We Focus on USO**

Our charitable donations for this quarter (Mar-May) are focused on the USO. Throughout the past year, despite the pandemic, the USO has continued to service our military community. As a congressionally chartered, non-profit organization, the USO relies on the generosity of individuals and organizations to support its activities. With the help of over 400 volunteers, including 2 from our chapter, the USO Northwest serves over 800,000 military and their families annually. Locally, your donations support the Shali Center at McChord Field, the Camp Lewis Center at Fort Lewis and the mobile program that services Washington and Oregon, as well as centers at Seatac and Portland airports.

The newest center, on Fort Lewis, is located inside the America’s Credit Union (ACU). They reopened in July and are open from 0900-1500, Monday – Friday, serving lunch 1100-1300 with a comfortable lounge area, computers, snacks all day in a café seating area. Along with serving as a pleasant sanctuary, they occasionally run special events, like Coffee Connection gatherings for spouses, or an evening when guests/families could get their portraits taken professionally, and enjoy a chicken dinner, just in time to gift the photos to parents/grandparents. While lunch at Fort Lewis is usually sandwiches and chips, the Shali Center offers a bit fancier spread with their kitchen arrangement ranging from hot breakfast to beef stroganoff and beyond.

To date, we have collected \$640 against a goal of \$1,400. Please consider supporting this program through your generous donations.

### **WDVA Assistance for Transitioning Service Members**

Don't wait until you separate from the military to apply for VA service-connected disability compensation. The Benefits Delivery at Discharge program allows service members to apply for VA disability compensation benefits between 180 and 90 days prior to separation from service. It can take quite some time for the VA to review your submitted paperwork, your medical records, schedule any necessary confirming medical exams and adjudicate your claim, so you want to get started as soon as possible. It is advisable to obtain the paperwork and start working with a professional to fill it out six months prior to your separation/retirement date to give yourself ample time. The WDVA can help. They can assist with the disability composition applications and provide a wealth of information on VA programs, such as home loans, VA medical, education benefits and much more. They can also provide information on state and local programs. ## **Saint Martin's University (SMU) Free Tax Preparation Service**

SMU senior accounting and finance students operate a certified free tax assistance program. The program serves those with incomes below \$58K, those with disabilities, limited English language skills and members of the SMU community. It runs every Saturday from now until April 9, on the SMU campus, in Harned Hall, 5000 Abbey Way SE, Lacey. Hours are 9am until 3pm. If you or someone you know is interested and qualified, you can contact Carrie or Slots (they have flyer with what to bring and directions to location).

## **COVID-19 At Home Test Kits Available**

Madigan is now distributing antigen-based COVID-19 test kits to TRICARE-eligible beneficiaries with a DoD ID card from 8am-12pm daily. Location: COVID Testing Site. Pick up requires an appointment. Appointments can be made at: <https://madigan.tricare.mil/covidtesting> If there are no appointments showing on a date, that means there are no appointments available. If you need to cancel an appointment, you use the same website. The test kits distributed at JBLM require a Smartphone to complete your self-testing at home.

## **FDA Approves 2<sup>nd</sup> COVID Booster Shot**

US regulators cleared second booster doses of Moderna and of Pfizer COVID vaccines for those adults 50 and older at least four months after receiving first booster shot, according to the Food and Drug Administration on Tuesday. The COVID-19 vaccine is available in all Madigan primary care clinics by appt, at Tricare network pharmacies, as well as at other community locations. ## **Concurrent Receipt Call to Action**

In the latest (April) issue of MOAA's monthly magazine, Military Officer, are two sets of pullout letters to the Democratic and Republican leaders of the U.S. Senate and House of Representatives, urging them to change the law prohibiting "concurrent receipt" of VA disability benefits and full military retirement pay, for veterans disabled in combat. Veterans' organizations for years have tried to get Congress to allow concurrent receipt for all disabled retirees, reasoning that these are two separate benefits and eligible retirees should not be "punished" by receipt of one causing the other to be reduced a like amount. Limiting a new concurrent receipt benefit to combat-related disability would be a significant step and appears to be winning over some in Congress put off by the cost of allowing it for all disabled retirees...

While it's true that the VA disability payment is not taxable, that benefit comes nowhere close to the loss caused by the current blanket prohibition of concurrent receipt of VA and military retirement benefits.

There are two sets of these letters in the magazine, one for the MOAA member and one for a spouse. Your Chapter leadership encourages members and spouses to fill in the blanks on the letters, tape (NOT staple) them shut, put stamps on them and mail them "asap!" Masses of letters like these, arriving from all over the country, do make an impression on Congressional members and their staffs. So please sign and send them...NOW!

## **From President Dana Atkins: Your Critical Role in This Year's Advocacy in Action (AiA) Campaign** (from The MOAA Newsletter)

Changing laws on Capitol Hill is arduous work. Legislation addressing critical issues can remain stuck in subcommittees through an entire two-year congressional session. Other bills can advance through committees only to lose momentum and die before reaching a floor vote. MOAA members can move these changes forward, but only if we're all pulling in the same direction. That's where Advocacy in Action comes in.

I encourage all MOAA members to take part in this campaign throughout April. Click the link above to send letters to your legislators, preparing them for calls from MOAA's state leaders and other volunteers who will be arranging meetings online and in person. Special focus will be put on interacting with these lawmakers during their state and district work period (April 11-22), when they will be more accessible to their constituents.

Watch for updates and future calls to action via *The MOAA Newsletter*, MOAA's [Advocacy News page](#), and [MOAA.org/AiA](#). We aim to reach 535 congressional offices with our AiA message, and we can't do it without your support.

We'll rally behind these three issues:

- **Concurrent Receipt for Combat-Injured Servicemembers:** The Major Richard Star Act (H.R. 1242, S. 344) would fix a longstanding injustice by allowing tens of thousands of combat-injured veterans to receive full retired pay and disability pay. The act has amassed 205 House co-sponsors, adding 54 since January, and is at a critical point as lawmakers draft the FY 2023 National Defense Authorization Act (NDAA).
- **Affordable mental health for TRICARE beneficiaries.** The Stop Copay Overpay Act (H.R. 4824) would overturn the doubling of TRICARE copays for mental health care in recent years. The bipartisan bill has only four co-sponsors, but additional momentum from your AiA efforts would improve chances of inclusion in the FY 2023 NDAA.
- **A 4.6% military pay raise.** This raise applies to all eight of our uniformed services; the percentage is linked to the Employment Cost Index (ECI) by statute. It remains one of MOAA's annual priorities to ensure the raise is not reduced to fund other programs or pay table overhauls – cumulative reductions over a recent three-year span (2014-2016) left servicemembers 2.6% below what they should have received.

We cannot contact every one of the 535 lawmaker offices on Capitol Hill without your help. Your legislators want to hear from you, [by any method](#).

MOAA is no stranger to success in these efforts. Many of you participated in our decades-long effort to repeal the “widows tax,” which [ended with success in the FY 2020 NDAA](#), or in letter-writing campaigns to help MOAA overturn “[COLA minus 1 percent](#)” and restore the full cost-of-living adjustment for retirees via legislation passed in 2014.

Our renowned advocacy work ranges from events on Capitol Hill to in-person meetings in your hometown with your legislators. Through both our national and local efforts, MOAA has been recognized for the 15th year in a row as a Top Lobbyist by *The Hill*, a highly respected publication in the competitive Washington, D.C., environment.

We can move mountains if we never stop serving. Thank you for being a part of this next chapter of success.

## Chapter Survey Results

The board received 27 surveys from chapter members. Thank you to those of you that replied, we do appreciate your feedback! It appears folks are eager to return to in-person meetings, though almost half would be most comfortable if all in attendance were vaccinated. The vast majority favor a return to Panorama, though some are interested in holding at least some meetings in other locations. While 36% favor continuing our current lunch – dinner schedule, 16% requested more dinner meetings, another 20% requested all dinner meetings, and another 20% indicated they were flexible concerning the lunch vs. dinner question. Individuals were nearly unanimously happy with current start times for lunch and dinner meetings.

For pricing options, when asked how much they would be willing to pay at Panorama, the average for lunch was about \$20-25, while the average for dinner was about \$25-35. When asked how much they would be willing to pay at a different venue, the average maximum for lunch was \$22 and for dinner was \$31. When asked how much they would be willing to spend for a drink, the most frequent responses were evenly split: “between \$5-8” and “don’t drink.”

All the survey respondents who have attended meetings expressed that they were highly satisfied, satisfied, or mostly satisfied with the programs and some did provide useful suggestions, which will be used by the VP for programming in planning future programs. Virtually everyone indicated they were content to contribute financially to our charitable causes and each respondent indicated their other areas of interest. All members who indicated an interest in serving as officers or board members are currently serving, so apparently we have some recruiting to do. The positive comments and praise for the officers and board members are greatly appreciated, as well as the assorted suggestions provided for improving the chapter. The officers and board members will use the suggestions in future event and strategic planning.

## In Person Meeting in April

While the survey reinforces that the chapter definitely wishes to return to Panorama when that becomes possible, there was also desire expressed to get together in person as soon as possible. With that in mind, our program VP has secured an excellent alternative plan for us for April. It has been two years since we have gathered together as a chapter in person. Time to celebrate this opportunity to get reacquainted with old friends and make some new ones.

We will be gathering at Rivers Edge, 4611 Tumwater Valley Dr SE, Olympia, WA, on Wednesday, 20 April. We will gather for cocktail/social at 5:30, with dinner served at approximately 6:00. We will be ordering individually off a special limited menu, with each party receiving a separate check. There are beef, chicken, seafood and vegetarian entrée options with prices varying from \$15-23. Salad, soup, desserts, and beverages, including alcoholic beverages, will be available for additional charges. As we are all ordering individually, we will be served individually, not necessarily at the same time, so we do ask that those attending order expeditiously, before getting caught up in socializing, to keep things moving smoothly. For this first meeting together in person we are forgoing a guest speaker to concentrate on getting acquainted/reacquainted with each other.

We do not need to preorder meals or collect money with this venue (they will generate separate checks), but we do need to get a head count to allow the restaurant to properly prepare for us. I have modified our usual dues/charity contribution form to again include a dinner RSVP line. You can print/cut it out and mail it to the chapter mailbox with your RSVP. Alternatively, you are welcome to call or email the chapter president or treasurer and let us know you plan to attend.

For Panorama residents, DeFrance Clarke has reserved a bus for transportation. He will need to provide names of those wishing to ride the bus to and from the dinner, so the right sized bus can be provided and residents’ accounts can be properly charged for the ride (\$3 each).
