**Time to Donate to Fisher House**

For 30 years, the Fisher House program has provided “a home away from home” for families of patients receiving medical care at major military and VA medical centers. These homes offer free, temporary lodging to military and veterans’ families, allowing them to be close to their loved one during a medical crisis and focus on what’s important – the healing process. There are 91 Fisher Houses located in the US, Germany and United Kingdom. We are fortunate to have two on JBLM. Fisher House Foundation receives 4 out of 4 stars from Charity Navigator and an A+ grade from Charity Watch. Along with providing free lodging, their Hero Programs allow donated frequent flyer miles and hotel points to be used to bring family members to the bedside of injured or ill service members, and the Foundation offers scholarships for military spouses and children

Fisher House depends on donations from individuals and organizations such as Olympia Area MOAA for the bulk of its funding. They also rely on the support of volunteers to help keep their houses feeling like homes, to assist in fundraising efforts and to explore donation options. ## **MOAA Crisis Relief Fund**

MOAA has approved a \$50K budget and rolled out a new Crisis Relief Fund modeled on the recently ended COVID relief fund. This new program is under the MOAA Foundation and offers those experiencing financial hardship due to a catastrophic event or crisis grants of up to \$500. Service members, spouses, veterans, caregivers and survivors are eligible, with preference given to those not eligible for support from the service relief societies or other organizations (an estimated 12+ million veterans). Should MOAA chapter members become aware of a catastrophic event or crisis in their area, and of impacted individuals who may be eligible for grants from this relief fund, they can serve as the intermediary to assist individuals to apply and to seek other resources identified by MOAA. ### **ACT NOW for Advocacy in Action (AiA) Campaign**

Dan Merry, MOAA Government Relations, recently addressed the need for MOAA chapter members to continue to go to the Legislative Action Center, if they have not already, to ask their Members of Congress to cosponsor/vote yes on the following:

- Stop CoPay Over Pay Act (HR 4824) in order to help get it added to NDAA as an amendment. This bill is about obtaining affordable mental health care for TRICARE beneficiaries.
- Health Care Fairness for Military Families Act of 2021 HR 475 (TRICARE Young Adult Parity) -cosponsored by Rep Kilmer, Strickland and Schrier so far.
- Toxic Exposure Reform (Honoring our PACT Act of 2021 bill) HR 3967 with 100 cosponsors and only Rep Kilmer, Larsen and Strickland in WA cosponsoring (as HASV Chair, Rep Smith does not cosponsor bills that might end up in the NDAA, but needs support from other Representatives to include in NDAA). **\*\*Senate will be voting on this one next week and we need to tell them to VOTE YES!**
- The Richard Star Act (S 344/HR 1282)—This bill is about concurrent receipt for combat-injured service members. Rep DelBene, Newhouse and McMorris Rodgers have NOT cosponsored in the House, and Sen Cantwell has NOT cosponsored in the Senate.
- Urge Your Legislators to Ensure the 4.6% Military Pay Raise as a Minimum.
- Expect NDAA markups to start first two weeks of June. **Action now is important. MOAA's new Legislative Action Center** can be found here: <https://moaa.quorum.us>

### June Chapter Meeting


