**This Quarter We Focus on USO**

Our charitable donations for this quarter (Mar-May) are focused on the USO. Throughout the past year, despite the pandemic, the USO has continued to service our military community. As a congressionally chartered, non-profit organization, the USO relies on the generosity of individuals and organizations to support its activities. With the help of over 400 volunteers, including 2 from our chapter, the USO Northwest serves over 800,000 military and their families annually. Locally, your donations support the Shali Center at McChord Field, the Camp Lewis Center at Fort Lewis and the mobile program that services Washington and Oregon, as well as centers at Seatac and Portland airports.

The newest center, on Fort Lewis, is located inside the America’s Credit Union (ACU). They reopened in July and are open from 0900-1500, Monday – Friday, serving lunch 1100-1300 with a comfortable lounge area, computers, snacks all day in a café seating area. Along with serving as a pleasant sanctuary, they occasionally run special events, like Coffee Connection gatherings for spouses, or an evening when guests/families could get their portraits taken professionally, and enjoy a chicken dinner, just in time to gift the photos to parents/grandparents. While lunch at Fort Lewis is usually sandwiches and chips, the Shali Center offers a bit fancier spread with their kitchen arrangement ranging from hot breakfast to beef stroganoff and beyond.

To date, we have collected **\$755** against a goal of \$1,400. Please consider supporting this program through your generous donations.

**Scholarship Program Update**

### **May Chapter Meeting**

We will gather at Rivers Edge, 4611 Tumwater Valley Dr SE, Olympia, WA, on Wednesday, 18 May. We will be ordering individually off a special limited menu, with each party receiving a separate check. There are beef, chicken, seafood and vegetarian entrée options with prices varying from \$15-23. Salad, soup, desserts, and beverages, including alcoholic beverages, will be available for additional charges. As we are all ordering individually, we will be served individually, not necessarily at the same time, so we do ask that those attending order expeditiously, before getting caught up in socializing, to keep things moving smoothly.

### **MOAA Crisis Relief Fund**

MOAA has approved a \$50K budget and rolled out a new Crisis Relief Fund modeled on the recently ended COVID relief fund. This new program is under the MOAA Foundation and offers those experiencing financial hardship due to a catastrophic event or crisis grants of up to \$500. Service members, spouses, veterans, caregivers and survivors are eligible, with preference given to those not eligible for support from the service relief societies or other organizations (an estimated 12+ million veterans). Should MOAA chapter members become aware of a catastrophic event or crisis in their area, and of impacted individuals who may be eligible for grants from this relief fund, they can serve as the intermediary to assist individuals to apply and to seek other resources identified by MOAA. ## **ACT NOW for Advocacy in Action (AiA) Campaign**

I guess my article last month did not move many people because MOAA has a tracker now and it appears almost nobody actually went online and sent emails to their legislators. I am asking as your chapter president – let your voice be heard! Our voices joined together can be very powerful in persuading Congress that we care about these issues. Please take note.

Click the link above to send letters to your legislators, reinforcing calls from MOAA's state leaders and other volunteers who have been arranging meetings online and in person. Special focus was put on interacting with these lawmakers during their state and district work period (April 11-22), when they were more accessible to their constituents. MOAA state and national officials are still working to reach 535 congressional offices with our AiA message, and they can't do it without our support.

We are rallying behind these three issues:

**Concurrent Receipt for Combat-Injured Servicemembers:** The Major Richard Star Act (H.R. 1242, S. 344) would fix a longstanding injustice by allowing tens of thousands of combat-injured veterans to receive full retired pay and disability pay. The act has amassed 205 House co-sponsors, adding 54 since January, and is at a critical point as lawmakers draft the FY 2023 National Defense Authorization Act (NDAA). These are earned benefits that they have every right to. We are very close to correcting this injustice.

**Affordable mental health for TRICARE beneficiaries.** The Stop Copay Overpay Act (H.R. 4824) would overturn the doubling of TRICARE copays for mental health care in recent years. The bipartisan bill has only four co-sponsors, but additional momentum from your AiA efforts would improve chances of inclusion in the FY 2023 NDAA. Mental health care has never been a more critical need for our veterans and family members and the copay costs are becoming prohibitive. Cost should never keep a member of our military family from getting the care they need most.

**A 4.6% military pay raise.** This raise applies to all eight of our uniformed services; the percentage is linked to the Employment Cost Index (ECI) by statute. It remains one of MOAA's annual priorities to ensure the raise is not reduced to fund other programs or pay table overhauls – cumulative reductions over a recent three-year span (2014-2016) left servicemembers 2.6% below what they should have received.

We cannot contact every one of the 535 lawmaker offices on Capitol Hill without your help. Your legislators want to hear from you, [by any method](#).

## **Veteran Suicide Prevention**

The 2021 VA Suicide Prevention Annual Report reflects 2001-2019 data. This report indicates that the overall veteran suicide rate for Washington state is 34.2%. It is highest for 18-34 year-olds. The report indicated that this WA state suicide rate is not significantly higher than the national veteran suicide rate, but it is significantly higher than the national general population suicide rate (18.0%). It behooves us to be aware of veteran suicide prevention measures in our state, such as the Veterans Crisis Line. *If you or someone you know is having thoughts of suicide, contact the Veterans Crisis Line to receive free, confidential support and crisis intervention available 24 hours a day, 7 days a week, 365 days a year. ## **VA's Program of Comprehensive Assistance for Family Caregivers**

The federal VA has a program that benefits veterans and their caregivers for eligible veterans who served either on or after September 11, 2001, or on or prior to May 7, 1975. It is for designated primary caregivers who live full time in the household. Benefits may include education, training, mental health counseling, travel, lodging, financial assistance when traveling with the veteran to receive care, a monthly stipend, access to health care benefits through the Civilian Health and Medical Program of the Department of Veterans Affairs and at least 30 days per year of respite care for the veteran. The eligibility is very specific. VA disability rating of 70% or higher with service-connected disabilities caused or made worse by active duty service during service periods mentioned above. Veteran must have been discharged from the U.S. military or have a date of medical discharge. Veteran must need at least 6 months of continuous in person care with activities of daily living such as eating, bathing, transferring, etc. We have so many veterans in need of services and this is one way for those who choose to keep their loved one at home to have some resources to mitigate expenses. Check the credentials of anyone reaching out after a death. "Blind faith in strangers can cause a lot of destruction. In most situations, you're better off erring on the side of caution and consulting with someone who you reached out to independently after thoroughly researching, rather than working with a professional who has reached out to you," says Nishank Khanna, CFO of Clarify Capital.
