### Time to Gear Up for Santa's Castle

Santa's Castle has provided Christmas since 1994 to the children of Army, Air Force, Navy, Marine, Coast Guard, National Guard and Reserve families experiencing financial difficulty. In 2021, 2,633 children from 1,245 families were served by Santa's Castle. A grand total of \$219,981 in toys, books, games, bikes, and stocking stuffers were given out.

Santa's Castle is operated entirely by volunteers. Their donors and volunteers are dedicated to ensuring the children of our military heroes receive Christmas gifts, making their holidays brighter.

Each year from September through November our MOAA chapter collects monetary contributions to be donated to Santa's Castle. The contributions are critical to making Santa's Castle successful in achieving its mission.

We also encourage any chapter members interested in volunteering to consider serving as elves at Santa's Castle, helping service members and spouses shop for their children at the castle. This year, toy distribution will occur November 28-December 2 and December 5-9. If you can spare the time, consider volunteering as an elf. It only requires a brief training session and then at least one 2-4 hour shift at the castle. Santa's Castle anticipates holding an open house 22 September from 4-7pm and training sessions in November. Volunteers need only attend one training session. #### **Federal Legislative Update and Call to Action**

House and Senate of the 117th Congress are on recess, returning mid-September. Veteran advocates scored a mega win with the newly signed PACT ACT, which adds 23 new presumptive conditions from toxic exposure as eligible for VA health care. There are approximately 3.5M service members who have been exposed to the toxic fumes in various deployed locations including Southeast Asia, Gulf War and post-9/11 eras. As the Beatles sang in 1970, "It has been a long and winding road" to achieving VA health care to fix health problems first detected in about 2004 with the appearance of inexplicable pulmonary complaints by service members. 18 years later, on August 10th, the President signed "The Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act" (PACT Act). Coverage is now extended from SWA victims to Vietnam Agent Orange victims to victims of the recent Camp Lejeune toxic water discovery. 14,000 messages from MOAA members flowed to legislators supporting this Act in the last four weeks prior to passage, 60 Veteran Service Organizations joined with MOAA to push this Act through despite last minute legislative gymnastics in the Senate. Lesson learned: Never give up. "Never Stop Serving." Many times, over the past six months, we were ready to "pop the champagne corks" only to have another hurdle appear. Hard core advocacy work overcame each and every obstacle. So, with that lesson learned in mind we need to keep an eye on the implementation of Act. Getting it signed into law will be a hollow victory without affected veterans actually getting meaningful care. Also, if long term relentless advocacy is the lesson learned from the "Widow's Tax" and the PACT Act efforts, we must exert the same determination to The Richard Star Act (H.R. 1282/S. 344).

This bill was introduced into the Senate in February 2021. It permits a veteran with a combat related disability and fewer than 20 years of creditable service to receive retirement pay and disability compensation concurrently without reduction. Over 50,000 medically retired veterans are forbidden from receiving their full retirement pay and disability compensation right now. The Major Richard Star Act would repeal this unfair offset, allowing these disabled Veterans to receive both their retirement pay and their disability. Reducing the retirement pay of combat-disabled veterans is just plain wrong. We must double down on previous efforts to encourage Congress to pass the Richard Star Act to eliminate this injustice...and in less than 18 years! And, that is an improvement over the 20+ years it took to get the Widow's Tax (SBP/DIC Offset) repealed. We cannot wait that long to correct this inequity.

The House version of the Act (H.R.1282) has passed 295 cosponsors. That is a magic number qualifying the bill for the House consensus calendar following a motion by its lead sponsor, Rep Bilirakis (R-Fla). That motion occurred on August 12. By House rules any bill on the consensus calendar is automatically forwarded to the floor for vote. One bill per week. This bill is the 8<sup>th</sup> bill on the calendar. While time is short, senior House members can waive budgetary rules and bring H.R. 1282 up for a vote. Senator Tester has agreed to push the Senate version, S-344, as an amendment to the Senate's draft of the FY23 National Defense Authorization Act.

Everyone is strongly encouraged to contact their Senators and Representatives and express their support for the Major Richard Star Act now.

Legislatively, we are trying to fill an inside straight to get this bill passed and signed this fiscal year given the small number of days remaining in the 117th congressional calendar. However, miracles rarely occur without Herculean effort. Passage of both the PACT Act and the Widow's Tax happened because of efforts from veteran support organizations like MOAA. Let's go for the hat trick with The Richard Star Act. Our disabled veterans deserve the effort.

## Survivor Benefit Plan (SBP)/ Dependency and Indemnity Compensation (DIC)

Congress made changes to the Survivor Benefit Plan (SBP) to phase out the offset for surviving spouses who are also receiving Dependency and Indemnity Compensation (DIC) from the Department of Veterans Affairs (VA).

On January 1, 2023, the SBP-DIC offset will be fully eliminated. SBP payments will no longer be offset (reduced) by DIC. Spouses will receive full SBP (issued by DFAS) and full DIC (from the VA). There is no action you need to take as a retiree for the changes to apply to your surviving spouse. However, you should check your RAS to ensure your SBP beneficiary is up to date. This is especially important if you have a former spouse. Find out more at: https://www.dfas.mil/SBPforspouse

Also, if your monthly premiums are not automatically deducted from your pay, you should ensure your account does not have unpaid monthly premiums. # <u>Surviving Spouse Corner – Military Retirees and Dependents with ID Cards that Don't Expire Need to Get Replacements within 4 Years</u>

Retirees and military family members who have identification cards with no expiration date can choose to upgrade to the new Next Generation Uniform Services Identification, or USID, cards whenever it's convenient – as long as it's done within the next four years, according to the Defense Department. There is no looming deadline for use of those old non-active duty cards without expiration dates, but the department expects to completely phase out and replace them with the next-generation IDs, which are more durable and have enhanced security features, by 2026.

The department recommends that those with old ID cards with no expiration date replace these cards at their convenience by going to "ID Card Office Online" (type that into your internet search engine without the quotation marks, or click on <a href="https://idco.dmdc.osd.mil/idco/">https://idco.dmdc.osd.mil/idco/</a>) and make an appointment at your nearest convenient ID card issuing office. Please pass the word to retirees and family members who don't get this newsletter.

Added note of clarification from one of our members who recently visited an ID card office based on this article and received the following guidance: if you have an ID card that still has your SSN on it, you definitely need to get it replaced. If you have an ID card that has your DoD ID number instead, then you are OK.
