MOAA Hot Legislative Action

Please join us once again in providing a counterpoint to CBO's written testimony by reminding Congress that our nation has an obligation to provide the health care benefit service members and retirees have earned. Proposed TRICARE For Life enrollment fees would cost Medicare-age beneficiaries \$575 a year for individual coverage or \$1,150 for family coverage.

Proposed cost-sharing measures would include an \$850 deductible, meaning TRICARE For Life would not cover any of the first \$850 of a beneficiary's Medicare cost-sharing.

After the deductible, the proposed cost-sharing plan allows TRICARE For Life to cover only 50% of the next \$7,650 in Medicare cost-sharing, meaning beneficiaries would pay up to \$4,675 in cost-sharing per year.
