# 2024 Olympia MOAA Scholarship

Several years ago, we decided to develop a scholarship program that has been successful in awarding five \$1000 scholarships each year. This year, our goal is again \$3000. We allow donations into the scholarship fund throughout the year, then make it our primary focus for donations December through February. With this approach, I expect that we will exceed the goal and allow us to award five scholarships again in 2024. We launched our program in the school districts at the beginning of the year and award the scholarships in the May-June timeframe. # Sports Ball Drive for Santa's Castle

MOAA team members gathered at the Olympia Elks Lodge on the 18th of November to collect and inflate sports balls, which they delivered to Santa's Castle to be distributed to military families for Christmas this year. The weather cooperated, the team played some Christmas tunes, the Elks provided space, electricity, tables and chairs and all necessary logistics support, even donating a handful of balls to the cause. This was a culminating event for the month-long project with significant donations of 232 balls from Olympic Peninsula MOAA and \$1,115 (bought 222 balls) from Puget



Sound MOWW Chapters helping to put us over 700 total balls for 2023. A big thank you to all chapter members who donated balls and funds and to those who came out on the  $18^{th}$  – many hands make light work.



# MOAA State Legislative Advocacy Summary

Jerry Fugich, Chairman of the Veterans Legislative Coalition (VLC), provided the following State Legislative update:



The VLC team are volunteers from an array of veterans' organizations passionate about advocating/lobbying for the needs of the entire military family. During the last six years, the VLC has made major improvements in employment opportunities for veterans and spouses. There have been 11 bills passed to improve veteran family employment. A major achievement this year was the Nurses Compact. Now the following medical related compacts are law: Nurses Licensure Compact, Interstate Medical Licensure Compact, Physical Therapy Compact, Psychology Inter-jurisdictional Compact, Audiology and Speech-Language Pathology Compact and the Dentist and Dental Hygienist Compact. There have been at least 4 bills for Education Assistance. There were 4 bills passed to provide property tax relief. **There are now 3 bills that established the Suicide Prevention 988 program**. There have also been two bills that will help our disabled veterans, one of which means they will not have to pay sales tax on their VA provided handicap vehicles. A total of 15 veteran/military related bills went to the governor's desk for signature this session – an unprecedented accomplishment for any lobbying organization.

## Volunteer Opportunity - Air & Space Forces Association - 100th Anniversary - Round the World Flight

After almost six months en route, two Douglas World Cruiser Aircraft completed the first Around the World Flight landing at Sand Point Airfield near Seattle on September 28, 1924. The fliers were supported by 36 ships while flying with pontoons when crossing the Pacific and Atlantic Oceans. This flight is considered the second most important aviation achievement, exceeded only by the Wright Brother first controlled flight at Kitty Hawk.

In commemoration of this historic event, planning has started on a **100th Anniversary** of the First Aerial Circumnavigation of the World, to be held on **Saturday**, **September 28**, **2024**.
