# President's Note

A very informative January meeting! I want to thank our members who joined us for an informative presentation by Colleen Carmichael and Tamra Ingwaldson. Colleen is the Executive Director of Quixote Communities, an agency that provides permanent supportive housing in Thurston, Mason and Pierce counties for people and veterans experiencing homelessness. Her organization uses a "tiny home villages" model to foster community, encourage personal growth, and promote access to care and services for village residents. Although the original "tiny homes" village in Olympia is open to all homeless who qualify, Colleen joined us to talk to us primarily about the "tiny home" villages in Shelton and at the Orting Soldiers Home that specifically support homeless veterans. She and her assistant, Tamra, shared a wealth of information that we will be posting on our website. In addition to coordinating for a tour of the Shelton village, our board will be looking for ways we can support this highly beneficial program.

As we look for ways to improve our operations and management, the board is in the process of migrating to Microsoft Teams. An excellent training session was conducted on Jan 20<sup>th</sup> with most board members in attendance. After the training, a decision was made to transition to using Teams starting with the February board meeting. One major advantage that using Teams will provide is the ability to create channels to archive the Chapter's historical records. This transition is possible through a Microsoft non-profit Teams grant.

Next, this past week, Mark Wiseman and I had an opportunity to hear from the St Martins University Computer Science Senior project development team who are working to create a MOAA App for our chapter. They are well on their way and we are at a place where it is time to demo the App for you. # Jerry Fugich, Chairman of the Veterans Legislative Coalition (VLC), provided the following State Legislative update:



The Veteran Legislative Coalition hosted their annual VLC Legislative Reception on 12 January, in the Columbia Room in the Legislative Building to thank the members of the

House and Senate and their staffs for their support in sponsoring and passing meaningful legislative action in support of military members and their families. Among the attendees was Governor Jay Inslee who publicly thanked VLC member Susan Woods and presented her with a card

signed by several of the attendees for all her hard work and coordination for the event. Our own Jerry Fugich was in the thick of things as Chairman of the VLC, welcoming the governor and presenting awards to some of our most staunch supporters in the house and senate. Chapter members Allen Acosta and Carrie Nielson also attended, enjoying the opportunity to interact with fellow VSO representatives and our government representatives.

The VLC is actively tracking over 30 bills before the House and Senate during the current Washington State Legislative session. They might attend hearings, provide testimony, speak to representatives or staffers, or just track status, as Appropriate for each bill as it moves through the process. ### Volunteer Opportunity - Air & Space Forces Association -100th Anniversary - Round the World Flight

After almost six months en route, two Douglas World Cruiser Aircraft completed the first Around the World Flight landing at Sand Point Airfield near Seattle on September 28, 1924. The fliers were supported by 36 ships while flying with pontoons when crossing the Pacific and Atlantic Oceans. This flight is considered the second most important aviation achievement, exceeded only by the Wright Brothers first controlled flight at Kitty Hawk.

In commemoration of this historic event, planning has started on a **100th Anniversary** of the First Aerial Circumnavigation of the World, to be held on **Saturday**, **September 28**, **2024**.

### NATIONAL AMERICAN INDIAN VETERANS ORGANIZATION CONGRESSIONAL CHARTER PASSES WITH FY24 NDAA

WASHINGTON – U.S. Senator Mike Rounds (R-S.D.), a member of the Senate Committee on Indian Affairs, today announced that the congressional charter for the National American Indian Veterans (NAIV) organization has passed as part of the National Defense Authorization Act (NDAA) for Fiscal Year 2024.

Congress grants charters to recognize patriotic and national organizations that operate solely for charitable, literary, educational, scientific or civil improvement purposes. The NAIV serves the needs and interests of Native American veterans in collaboration with its national leadership and 14 regional offices. According to the Department of Veterans Affairs, there are more than 140,000 Native American veterans in the United States. While congressional charters have been granted to Italian-American, Polish-American and Catholic-American veterans groups, no Native American veterans' organization had received one.

Headquartered in South Dakota on the Cheyenne River Sioux Tribal Reservation, the NAIV is a nonprofit, nonpartisan organization dedicated to advocating on behalf of tribal veterans. Originally established in 2004, today the NAIV serves the needs of Native American veterans in all 50 states. The NAIV formed as a result of a request by former Senators Daniel Akaka (D-Hawaii), Daniel Inouye (D-Hawaii) and Ben Nighthorse Campbell (R-Colo.) during a Senate Veterans' Affairs Committee hearing in 2004.

Rounds and Senator Ben Ray Luján (D-N.M.) first introduced this legislation, which grants a congressional charter for the NAIV, in the 116th Congress and again in the 117th Congress, where it unanimously passed the Senate.

"Native Americans serve in our nation's military at five times the national average, and this charter gives them the recognition they truly deserve and have earned," said Rounds. "The NAIV works closely with Tribal Veterans Service Officers to make certain Native American veterans receive proper benefits and resources. Congress regularly looks to the NAIV for input when addressing issues facing Native American veterans. This charter will help give the NAIV a larger platform to continue advocating for and serving the more than 140,000 Native American veterans living in the United States. I am pleased to have had it included as part of this year's NDAA."

### Remembering Ben Adkins

It is with heavy heart we must bid **fair winds and following seas to our dear colleague, Ben Adkins**. Ben passed away January 10. His Memorial Service was January 30, and his burial service was held at Tahoma Cemetery with full military honors on January 31. Ben was a lifetime MOAA member, as well as loyal member of local VFW and American Legion chapters and he and his wife, Judy, had been frequent meeting attendees since we returned to in person meetings post-COVID. Ben proudly served in the USAF for 23 years, retiring as a Major. Ben served in Vietnam, where he earned a Bronze Star. After his military service, he served the state of Washington, first in the Office of Financial Management and then as the Deputy Director of Capitol Buildings and Grounds. After serving for a time as a Senior Research Scientist and Group Manager at Battelle Memorial Institute, Ben ran his own consulting firm until he fully retired in 2013. Ben is survived by his wife, Judy, and daughters, Michelle and Lori.
