The key issues selected by MOAA for this year's AIA are:

- 1. Improving unaccompanied housing to support readiness and quality of Life.
- 2. Advancing the report Ending the Wait for Toxic Exposed Veterans to ensure timely delivery of benefits.
- 3. Passing the Military Spouse Hiring Act to expand employment opportunities.
- 4. Enhancing stability and accountability in the military health system.
- 5. Improving caregiving support for families of veterans.

As for the scholarship program, to date, 35 students have applied and of the 35, 23 have submitted complete applications. Given available funding, we should be able to award 3 or 4 scholarships. Also, we are looking for judges to score the applications and if you are interested, please contact either Bill Moseley, Carrie Nielson or myself.



# In Memory Of Barbara Eskridge Lind

May 29, 1930 - February 23, 2025

Barbara was born in New London, CT, on May 29, 1930, as the only child of Ira E. Eskridge and Emily E. Rowland Eskridge. Her father was in the Coast Guard spending forty years at sea and rising to the rank of Rear Admiral. Barbara and her future husband, Carl Bradley Lind, met at a regional high school forensics meet (when family lore says they somehow ended up washing dishes together). They dated throughout college – Carl B. was a military cadet, at Norwich University, while she was a student at Smith College in Northhampton, MA. They fell in love and married at Smith College on October 22, 1951, after Carl was commissioned as a Lieutenant in the US Army. The next year Barbara graduated from Smith, and the couple reunited across the Atlantic where Brad was deployed at various Army posts in Germany. All their earthly belongings fit in two military footlockers.

Barbara was the quintessential Army wife and the family soon grew with the births of Garry, Susan, and Craig. The new Army family served around the world before Barbara and Brad retired to Washington State in 1983. Always having a strong urge to travel and learn about the world, the couple lived, traveled, and experienced locations throughout the US



as well as Europe, Mexico, Southeast Asia, China, Morocco, Peru, Australia, and many other fascinating destinations. Barbara was a tiny woman with a huge heart.

Barbara was preceded in death by her husband, Carl B. Lind, and her beloved grandson, Ira Daugherty. Barbara is survived by her three children: Carl G. Lind (Arnesa), Susan Daugherty (Brock), and Craig I. Lind; she was also serendipitously blessed with grandchildren and great-grandchildren: Jennifer Brown (Nolan), James Lind, Devon Emerson (Brian), their children Avery and Wyatt, Shannon Zahuranec (Baron), and their children Evan and Elin. She is also survived by Ira Daugherty's son Alec.

Her grandchildren and great-grandchildren were beloved by her, and Barbara had a lifelong curiosity and joy about the world in which we live, and encouraged those values of lifelong learning in her descendants throughout her life. If she was asked any question, if she didn't already know the answer (as usual), she would make it a personal quest to research the subject and find and relate the detailed answer. And – in all likelihood – send you newspaper and magazine articles about it for the next several years.

Interment will be at Arlington National Cemetery at a future date, when Barbara will rejoin her husband Carl B. Lind. She will be buried in the dress she wore at their first meeting, almost 75 years earlier. Their final resting place is near where their grandson Ira is interred.

In lieu of flowers, the family suggest donation to a favored charity, Wolf Haven International (wolfhaven.org). A Celebration of Life for Barbara will be held on Saturday, May 31st, at the Olympia Country Club, from 3pm to 6pm.

House Bill 1102 passed the House and is working its way through the Senate. This bill is about providing enough Veterans Service Officers throughout the state, especially in rural areas, to ensure our veterans obtain the earned benefits they are entitled to. Jerry Fugich urges chapter members to use the website we learned about at January's chapter meeting to go online and let our representatives know we strongly support passage of this bill. # **Member of the Month - Frank Hensley**

Retired Navy Captain Frank Hensley lives with his spouse, Marlyce, in Tumwater. These days he and Marlyce enjoy their backyard with its squirrels, fishpond and fruit trees, along with their pet cat, many friends, together with somewhat limited travel and visits from Frank's children and grandchildren.

Frank was born and raised in Seattle, attending James Monroe Junior High School, Lincoln High School and the University of Washington. He was a member of the Navy ROTC then left for his first duty station, Supply Corps school at Athens, Georgia. All Supply Corps Ensigns from schools all over the country were sent there for indoctrination. This was the school's first year at Athens, which was also the home of the University of Georgia. It was summertime and the summer term at the U of Georgia was almost devoid of female students. So here was a class of over one hundred handsome young men, just graduated from college, mostly single, with sparkling new uniforms and a few coins in their pocket and nary a coed in sight. A few Ensigns were actually dating high school girls. But word got around fast and the second summer

saw enrollment at the U of Georgia experience an astonishing increase in the number of coeds who signed up for summer quarter. Rumor has it that an unusually high proportion of Supply Corps wives have that delightful southern accent.

Frank's Naval Service included several shipboard assignments and land assignments in Japan, the Philippines and (of all places) Indiana. There he was assigned to the Inspector of Naval Material office where he negotiated contract changes with suppliers and was a trouble-shooter for all sorts of problems with suppliers of Naval material and weapons. But after 10 years of active duty and long separations from wife and children while ships were at sea, he had enough. He left the active duty Navy and went back to school for an MBA. This was followed by jobs at King County doing similar work, and finally in Olympia working for the state Legislature reviewing the accomplishments and problems of various programs and federal and state legislation. Frank retired in 1991 from both the State of Washington and the Naval Reserve, followed by extensive travel "just for fun".

He stays active with memberships in the Retired Public Employees state and national organizations and served 8 years on the state Medical Commission.

Frank has three children by a previous marriage, two of which are retired, and two grandchildren he is very proud of. His grandson is an engineer who designs material movement equipment, and his granddaughter is just finishing her training to manage various forms of pharmacies---in hospitals, major drug stores and other variations.

Frank would like to see MOAA provide visits to disabled former servicemen. Thinks this would be a good activity for aging members of MOAA who cannot participate in the garden or firewood projects. The VFW already has such a program so it would be necessary to avoid any conflict with their program.
