As a surprise, Cindy recognized all those present who served during the Vietnam War with a special recognition pin in honor of and in thanks for their service. It was a special moment for our Vietnam era members as one member expressed to me that for him, it was the first time anyone ever thanked him for his Vietnam War service. Khushi, one of our four scholarship recipients is an incredibly bright, articulate student who shared with us her future plans to attend UW. Also present as guests were Lauri's spouse CSM (R) Richard Leirdahl and Kushi's mother, Anshu Gupta. Our other scholarship recipients plan to attend the June meeting.

Coming in June is the USO Golf Tournament on Thursday, June 19th. This event is the USO PNW's largest fund raiser and once again, we will be selling, "pitch-a-balls." Fisher House provides service members and their families a comfortable, nurturing and secure home away from home when they receive medical care at Madigan Army Medical Center. The JBLM Fisher House can serve 18 families inhouse with their two facilities and other eligible families at off-site locations completely free of cost. Fisher House worldwide has housed over 500,000 families, saving military families over \$610 million in lodging, food and transportation costs. This is what your donations this quarter will support! State Legislative Update

Chapter member Jerry Fugich, chairman of the Veterans Legislative Coalition reports the governor signed a bill which will help expand the availability of Veterans Service Officers, particularly in rural parts of the state, to ensure veterans receive all the benefits they have earned. The governor also signed a bill which permits veterans with 70% or greater disability, who have a service animal, to apply for a handicap parking placard. In the next session, the VLC will be prioritizing a bill for property tax relief for veterans based on percent disability.

2025 ADVOCACY IN ACTION ISSUES - From the MOAA email

Greetings from MOAA!

While our MOAA representatives have returned home, we still need to keep up the press to reach out to every congressional office in every way possible. Together, we delivered a unified message: **Congress must do all that it can to protect service-earned pay and benefits.**

Lawmakers need to keep hearing from constituents like us. The work done on Capitol Hill in one week must be reinforced by MOAA advocates from across the country. We urge you to take action on MOAA's top legislative priorities by sending emails, writing letters, making phone calls, even visiting their offices in person, whatever means of contact you are comfortable with, to talk to your representatives and advocate for these important issues:

- Incentivize Military Spouse Hiring: Actions to combat stagnant, high rates of unemployment among military spouses must include measures to incentivize their hiring. Cosponsor the Military Spouse Hiring Act to add a military spouse target group to the Work Opportunity Tax Credit program.
- <u>Unaccompanied Housing Improvements</u>: Transparency is key to supporting lawmaker oversight of this ongoing issue and addressing a \$137 billion maintenance backlog. Ask Congress to require DoD to make reports on unaccompanied housing installation conditions publicly available.
- Ending the Wait for Toxic-Exposed Veterans: Pass legislation to shorten how long millions of veterans must wait before receiving service-earned care and benefits.
- <u>Support Veteran Caregivers</u>: Champion/cosponsor the passage of the Veteran Caregiver Reeducation, Reemployment, and Retirement Act.

And don't forget — every message does make a difference. The pressures on service-earned pay and benefits aren't going away — but neither is MOAA.

We need every voice and every advocate to help us keep fighting, and to remind Congress that the greatest asset to our nation's security and prosperity is not a weapon system — it's the men and women in uniform and their families.

Attention Military Retirees: New ID Card Required by 2026

Beginning in 2026, the old-style, colored ID cards will no longer be accepted, regardless of the printed expiration date. This means even if your card says "indef", if it is on the old colored stock, it will no longer be accepted in 2026. To maintain base access, please visit your nearest DEERS/ID card office to obtain a new ID. You do not need to wait until the expiration date.

Before you go to the military installation, you should make an appointment to get a new card through the RAPIDS ID Card Office Online: https://idco.dmdc.osd.mil/idco/ It is possible you will be able to obtain a card online, depending on your circumstances.
